## Lead Based Paint Certified Renovator Training – Initial (Full Day)

The new EPA Lead-Based Paint (RRP) regulation, which went into effect April 22, 2010, applies to residential houses, apartments, and child-occupied facilities (e.g. schools, child-care centers, hospitals) built before 1978.

**Who needs the training?**

RRP is a federal regulatory program impacting contractors, property managers, and others who receive payment for services. Anyone who is paid to perform work in pre-1978 housing and child-occupied facilities and disturbs more than 6 square feet inside, more than 20 square feet outside, or repairs or replaces windows, needs this training. This includes – but is not limited to – contractors, carpenters, painters, plumbers, water damage restoration firms, electricians, drywall installers, HVAC technicians, window and door installers, residential property managers, and many more.

**How can you get trained and certified as a Renovator?**

Successfully complete the 8-hour initial renovator training course. The course includes a lecture portion as well as hands-on activities. Students will be tested at the end of the course. Those earning a passing score on the exam will receive a EPA Certified Renovator certification that will be valid for 5 years.

- Why you should be concerned about lead paint
- Regulations related to lead
- Setting up your work area
- Containing lead dust when working
- Cleaning up your work area
- Verifying that your work area is clean
- Recordkeeping
- Training non-certified renovation workers
